

# Conditions for submission of papers to International Journal of Materials Research

## 1. Manuscript preparation

### 1.1. Language

All manuscripts should be written in good English. Poorly written papers will be automatically returned for rewriting before review. Both British and U.S. English are acceptable but authors should be consistent in their usage.

### 1.2. Style

Manuscripts must be prepared according to the IJMR Style Guide, available at [www.ijmr.de](http://www.ijmr.de); simply click on “submit a paper” and then download the guide in pdf format or download from the submission website <https://www.editorialmanager.com/ijmr/>. The layout is designed to speed up the publication of your paper. What we need from you the authors is a document that we can review and edit easily. Please do not try to emulate the final journal lay-out style. Follow the Style Guide carefully in order to save yourself subsequent time-consuming corrections after your paper has been reviewed and edited. After reviewing and editing, papers will be returned to authors for final revision when the authors should be make all recommended content and editorial changes. It is the authors’ responsibility to ensure their paper is in the “house style” before it can finally be accepted for publication.

### 1.3. Paper length

Generally, the length of the manuscript (without figures) of a regular paper should not exceed around 6500 words and may be shorter. A manuscript longer than 25 double-spaced typescript pages may be returned by the editor to the authors, without it having been refereed, with the remark that it must be shortened before being reconsidered. The maximum number of figures is about 8.

### 1.4. Short Communications

IJMR also accepts short communications for publishing interesting results quickly, without the need for writing a full paper. Short Communications should take up no more than 2 pages in the journal – see our Style Guide for full details.

## 2. Manuscript submission

Submission of a manuscript implies it is not being simultaneously considered for publication elsewhere and that the authors have obtained the necessary authority for

publication.

Submissions should be made using the online manuscript submission system **only** – Editorial Manager™. Please register yourself at the journal paper submission web site at <https://www.editorialmanager.com/ijmr/>. After Login into the system as an author you can upload your manuscript, having made sure that it conforms to the IJMR style – see *our Style Guide*.

## 2.1. Text and image file formats

- Acceptable manuscript file formats are MS Word and LaTeX.
- Illustrations should be uploaded in separate files:  
We recommend the following formats: TIFF, EPS, high quality JPG, GIF, or MS Office files – Powerpoint, Word, Excel (images cannot be accepted in pdf files). Suggested resolutions are: for TIFF and MS Office any images should have a resolution of  $\geq 1000$  dpi for line images,  $\geq 300$  dpi for grey-scale and colour images and  $\geq 500$  dpi for combinations of line and grey-scale. Images placed in MS Office applications should not be reduced or enlarged after placement. When including graphs, please make an image of the final graph instead of using files containing all the original data, as these are unnecessarily large. Authors are responsible for ensuring a sufficiently high resolution of images for print reproduction of figures *whilst maintaining a reasonable file size*.

A PDF File will be created at the end of the submission process. Please view and approve it to submit your manuscript to the journal office. We recommend using the latest version of Adobe Reader. Papers which do not follow the instructions below may not be accepted for publication (or publication will be delayed).

## 2.2. Nominating reviewers

The author(s) should provide the names and **correct** e-mail addresses of three possible reviewers. Only one of these three proposed referees may have an affiliation in the same country as holds for the first author.

## 2.3. Galley proofs

After acceptance and before publication, authors will receive **galley proofs** which they should correct and return as soon as possible to the Editorial Office. At the proof stage corrections are restricted to typesetting. No changes in, or additions to, the edited manuscript will be accepted. Galley proofs will include the paper's DOI (digital object identifier <http://www.doi.org/>) allowing the work to be cited. After galley proof corrections have been approved the paper will be published online in the "e-first" section of [www.ijmr.de](http://www.ijmr.de). Subsequently the paper will also be published in the monthly hard copy version of IJMR.

### 3. Fees

No honorarium will be paid and no page charge will be made. Costs for corrections not due to the printers will be charged to the authors. The fees for colour reproduction are presently:

- Print AND online: 100 € per coloured figure, maximum 490 € for 5 or more figures.
- Online ONLY: 100€ flat rate

### 4. Authors-run-on-prints

Run-on-prints (minimum 50 copies) can be ordered when the proofs are returned, i.e. before printing. No free run-on-prints will be provided.

### 5. Copyright

The publisher assumes that the authors of a submitted manuscript have the exclusive disposal of the article or acts in this sense fully authorized, that furthermore the article has not been published or submitted complete or in part elsewhere and that all authors have agreed on submission of the article in the present form. The publisher must be informed about deviations from this on handing in the manuscripts. Consequences resulting from non-observance of this regulation are chargeable to the author: With publication of the manuscript, the exclusive copyright and all accessory rights devolve upon the publisher.
